Original Narrative Supplemental Narrative

On August 23, 2008 at approximately 0029 hours, I observed Kinley walk through the Tate Center Plaza. Kinley appeared to stagger a couple of times as he walked through. I then watched as he began walking down East Baxter Street towards Lumpkin Street. Kinley had begun to stagger more drastically from his left to right as he walked. I made contact with Kinley at the intersection of East Baxter Street and Lumpkin Street and smelled a strong odor commonly associated with alcoholic beverages coming from his breath. Kinley then attempted to cross Lumpkin Street against the light and began to step out in front of an approaching vehicle. After getting Kinley back on the sidewalk I asked him for his identification which he provided and which indicated that he was twenty years old. Subsequent investigation led to the discovery of fixed blade knife with a blade length of 4 1/8" in Kinley's waistband. A 31" chain with a 5 1/4" metal handle was then located in Kinley's pants pocket. An altered identification was also found in Kinley's possession who made the post Miranda statement that he had used it to gain entry to a bar in downtown Athens earlier that night. Kinley also admitted to consuming alcohol on the same day.

Kinley was placed under arrest and transported to the Clarke County Jail where he was released, along with his property to Jail personnel. The knife, chain, and altered identification were placed in evidence. In addition to the charges listed on the cover sheet, Kinley was also charged with two counts of possession of a weapon on school property.
