NARRATIVE:

1 WHILE ON PATROL ON SR316 EB I SAW A SILVER CHEVY MONTE CARLO DRIVING IN THE LEFT LANE. WE WERE JUST WEST OF DULUTH HWY WHEN I
2 FIRST SAW THE CAR. THE SILVER CHEVY SEEMED TO BE HAVING A HARD TIME STAYING IN ONE LANE. THE CAR WAS DRIFTING FROM THE LEFT LANE
3 INTO THE RIGHT LANE AND BACK IN A VERY SMOOTH MANNER. I WATCHED THE CAR DO THIS SEVERAL TIMES. THE CHEVY THEN DRIFTED OVER TO
4 THE RIGHT LANE AND ONTO THE SHOULDER OF THE ROAD. THIS OCCURRED JUST EAST OF DULUTH HWY. THE DRIVER THEN CORRECTED AND STAYED
5 IN THE RIGHT LANE. THE CAR DRIFTED ONTO THE SHOULDER OF THE ROAD A FEW MORE TIMES BEFORE WE REACHED THE COLLINS HILL
6 INTERSECTION. I PULLED IN BEHIND THE CHEVY AS WE CROSSED THROUGH THE COLLINS HILL INTERSECTION. THE CAR DRIFTED BACK AND FORTH
7 WITH IN HIS LANE AND THEN ONTO THE SHOULDER AGAIN AS WE DROVE JUST EAST OF THE BUFORD DRIVE INTERSECTION. I MADE THE TRAFFIC STOP
8 ON 316 EAST JUST WEST OF HI HOPE ROAD.

10 I MADE CONTACT WITH THE DRIVER AND ASKED TO SEE HIS LICENSE. I ADVISED HIM THAT I WAS PULLING HIM OVER FOR THE MULTIPLE LANE
11 VIOLATIONS. I COULD SMELL A STRONG ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM THE INSIDE OF THE CAR. THE DRIVER LOOKED AT ME AND
12 I COULD SEE THAT HIS EYES WERE BLOODSHOT AND VERY WATERY. I ASKED THE DRIVER HOW MUCH HE HAD TO DRINK TONIGHT. THE DRIVER TOLD
13 ME THAT HE HAD A FEW DRINKS. I ASKED THE DRIVER WHERE HE WAS COMING FROM. THE DRIVER TOLD ME THAT HE HAD BEEN AT A GIRLS HOUSE. I
14 ASKED HIM WHAT HE HAD BEEN DRINKING. THE DRIVER CLIPPED HIS HEAD IN HIS HANDS AND SAID " PLEASE, PLEASE, PLEASE, I AM BEGGING YOU NOT
15 TO DO THIS, YOU WILL RUIN MY CAREER." I ASKED THE DRIVER TO STEP OUT OF HIS CAR.

17 ONCE OUT OF THE CAR, I EXPLAINED TO THE DRIVER THAT I WANTED TO RUN HIM THROUGH SOME FIELD SOBRIETY EVALUATIONS. THE DRIVER TOLD
18 ME THAT HE KNOWS THAT HE HAD BEEN DRINKING AND THAT HE WAS ONLY GOING TWO MORE LIGHTS UP THE ROAD AND THEN HE WAS GOING TO HIS
19 MOM'S HOUSE. THE DRIVER THEN ASKED ME IF I COULD JUST FOLLOW HIM HOME. I ASKED THE DRIVER AGAIN IF HE WOULD SUBMIT TO THE FIELD
20 SOBRIETY EVALUATION SO I COULD DETERMINE IF HE WAS SAFE TO DRIVE OR NOT. THE DRIVER AGREED.

22 THE FIRST EVALUATION WAS THE HGN. ONCE I HAD QUALIFIED THE DRIVER AND LEARNED THAT HE WAS NOT WEARING CONTACTS AND THAT HE WAS
23 TWENTY YEARS OLD, I BEGAN THE INSTRUCTIONS. THE EVALUATION WAS CONDUCTED AND THE DRIVER WAS TOLD TWICE TO HOLD HIS HEAD STILL.
24 THE DRIVER EXHIBITED SIX OUT OF SIX CLUES DURING THIS EVAL. THE SECOND EVAL WAS THE NINE STEP WALK AND TURN. THE DRIVER MISSED
25 HEEL TO TOE TWICE AND STEPPED OFF LINE ONCE DURING THE SECOND NINE STEPS. THE ONE LEG STAND WAS NEXT. THE DRIVER HAD TOLD ME
26 EARLIER THAT HE WAS A UGA BASKETBALL PLAYER. I CONFIRMED WITH HIM SEVERAL TIMES THAT HE WAS IN GOOD SHAPE. THIS TIME WHEN I ASKED
27 HIS IF HE HAD ANY PROBLEMS WITH HIS LEGS, THE DRIVER TOLD ME THAT HE WAS IN REHAB FOR HIS LEFT KNEE. THE DRIVER WAS TOLD ABOUT THE
28 ONE LEG STAND AND THE DRIVER TOLD ME THAT HE WAS OK. THE DRIVER LIFTED HIS LEFT LEG FOR THE EVAL. I NEEDED TO TELL HIM TO LOOK AT HIS
29 FOOT. THE DRIVER EXHIBITED A SLIGHT SWAY DURING THIS EVALUATION AND ONLY LIFTED HIS FOOT ABOUT 2 INCHES OFF THE GROUND WITH HIS
30 TOES POINTED UP. THE DRIVER REGISTERED .082 GRAMS ON THE ALSO. THE DRIVER WAS PLACED UNDER ARREST FOR DUI AND FAILURE TO
31 MAINTAIN A SINGLE LANE. THE DRIVER WAS SLIGHTLY HESITANT TO TURN AROUND WHEN ASKED TO. THE DRIVER WAS ADVISED THAT IF HE DID NOT
32 TURN AROUND, HE WOULD BE SHOT WITH A TASER. THE DRIVER WAS THEN PLACED IN DOUBLE-LOCKED HANDCUFFS. WHILE STANDING ON THE
33 ROADSIDE AFTER HE WAS CUFFED, I READ THE ORANGE IMPLIED CONSENT CARD FOR DRIVERS UNDER 21. THE SUSPECT GAVE A VERBAL YES TO THE
34 STATE ADMINISTERED BREATH TEST. SGT ASENZO PLACED THE SUSPECT INTO THE BACK SEAT OF HIS CAR.

36 THE CHEVY MONTE CARLO WAS IMPOUNDED WITH LANCE WRECKER SERVICE. DURING THE INVENTORY, I LOCATED A HALF FULL QUART BOTTLE OF
37 BACARDI RUM IN A BLACK BACK PACK ON THE BACK SEAT. THE BACK PACK ALSO HAD A TANK TOP AND A PAIR OF FLIP FLOPS IN IT.

39 THE SUSPECT WAS TRANSPORTED TO THE COUNTY JAIL WITH ME FOLLOWING. I TOOK CONTROL OF THE SUSPECT AGAIN IN THE SALLY PORT OF THE
40 COUNTY JAIL. ONCE THE SUSPECT WAS LOGGED IN, I EXPLAINED THE INTOX 5000 INSTRUMENT AND DEPUTY OZALUK ADMINISTERED THE INTOX 5000.
41 THE SUSPECT REGISTERED A LOW SAMPLE OF .129 GRAMS AT 0356 HOURS. THE SUSPECT WAS SHOWN HIS RESULTS AND TURNED OVER TO THE
42 DEPUTIES
