I responded to the Cabana Club located at 619 Ponte Vedra Blvd in reference to a accidental shooting. Dispatch advised that a subject had accidentally shot his foot in the parking lot. Upon arrival I met with Timothy Lewis, a security guard for the Cabana Club, who stated that he was advised by a fellow employee that someone had a gun in the parking lot. As T. Lewis went to see if this was true, he heard a loud pop and found a white male kneeling over in the parking lot with a gun shot wound to his left foot. T. Lewis immediately notified the authorities. I observed a black in color shotgun laying on the pavement beside

the victims vehicle and also a bloody flip-flop with a hole in the toe area. Dep. Grizzard #3207 who was also on scene immediately secured the shotgun in his patrol vehicle. Also upon arrival members from Fire/Rescue #10 were already on scene tending to the victim of the gunshot wound who was later identified as Amar Yakhou by his Georgia drivers license. Rick Casto with engine #10 advised me that he was told by by-standers that the victim, A. Yakhou, had previously pointed the gun at someone before accidentally shooting himself. He also advised that A. Yakhou's injuries were not life threatening and that he suffered a gunshot wound to one of his left toes. R. Casto stated that A. Yakhou would not be going to the hospital due to refusal. Once treated A. Yakhou was secured and placed in the rear of my patrol vehicle pending further investigation into the matter.

After further investigation it was determined that an altercation had occurred between A. Yakhou and other subjects and that a gun was involved. These subjects were inside the club with members of management. Dep. Alexander #3204 went inside to bring the subjects outside. I informed A. Yakhou I would be conducting an investigation and read him his constitutional rights from a rights card. A. Yakhou stated he understood his rights and agreed to speak with me. A. Yakhou advised he was on the beach when a group of guys began to harass him because he was from Georgia. He advised they argued for awhile before they followed him to his vehicle in the parking lot. A. Yakhou stated he pulled a gun from his vehicle in an attempt to scare them away. Once they left him alone he went and got his girlfriend and her sister from the beach to leave. As he was moving the gun from the backseat he discharged the firearm accidentally striking himself in the left foot. A. Yakhou stated at no time did he point the weapon at anybody. I then questioned A. Yakhou's girlfriend, Ashley Burns, and her sister, Elizabeth Burns, about the incident. They both stated that they were on the beach with A. Yakhou and were teased by a group of individuals on the beach because they were from Georgia. They advised A. Yakhou became angry when the group began to insult them. They advised that they all went to the parking lot while they stayed behind. They don't know what happened in the parking lot and never saw A. Yakhou point a gun at anyone. They advised that A. Yakhou returned to the beach and told them they needed to go before things escalated. E. Burns stated that A. Yakhou was attempting to put the shotgun in his trunk when it accidentally went off. E. Burns also advised that the group of guys walked by and told A. Yakhou that this was their beach and laughed at A. Yakhou yelling he got what he deserved.

Dep. Alexander #3204 returned to the parking lot with the other subjects involved, Robert Bauwens and Corey Dovel. R. Bauwens stated that he was confronted by A. Yakhou in reference to buying some marijuana. R. Bauwens told him that he doesn't use drugs nor did he know where to get some. He advised A. Yakhou continually asked him and offered him Xanax pills in exchange. R. Bauwens stated he walked away to see his girlfriend. R. Bauwens advised at some point the two had words again before he finally decided to leave for the day. While walking through the parking lot to his vehicle R. Bauwens explained he walked passed A. Yakhou who was also in the parking lot. R. Bauwens stated that A. Yakhou asked him a question then pulled a shotgun from out under a shirt and aggressed him with it pointing it at his face. R. Bauwens advised that A. Yakhou loaded a round into the shotgun and ordered him to call himself a "bitch" while continuing to point the gun at his face. R. Bauwens stated he did what A. Yakhou asked until he put the gun back under his shirt and returned to his vehicle. R. Bauwens stated he was in fear of losing his life during the incident. R. Bauwens stated he ran for help as soon as he thought it was safe to. R. Bauwens also stated that before he ran away, he grabbed the spent shotgun shell from the ground. This shell

I then spoke with Corey Dovel who did not see the incident but was aware of what occurred on the beach. C. Dovel stated that A. Yakhou first approached him about the marijuana and he told him that he didnt have any nor did he use it. As a joke he told A. Yakhou to go ask his buddy Rob for some. C. Dovel stated that A. Yakhou became angry with them and began to verbally attack them. C. Dovel advised that R. Bauwens left before him and was unaware what had occurred until R. Bauwens informed him of it.

During my conversation with R. Bauwens and C. Dovel, Dep. Alexander #3204 spoke with A. Yakhou and was able to get a full confession from him. He told Dep. Alexander that he did point the weapon at R. Bauwens but only because he was scared of what he was going to do to him. Dep. Alexander had him complete an affidavit.

At this time A. Yakhou was placed under arrest for aggravated assault with a deadly weapon.

Dep. Grizzard took 13 digital photos of the scene. The bloody flip-flop was also collected. All these items to include the shotgun were submitted into evidence.

Forfeiture/seizure papers were completed on A. Yakhou's vehicle and was towed from the scene by Al Tow and stow, and transported to the impound lot at the sheriffs office.

A. Yakhou was transported to the county jail without further incident.

It should be noted that a possible witness by the name of Keri Dowd (273-0281) left the scene before our arrival. The manager at the Cabana Club provided us with her information. K. Dowd was not reached at this time due to the late hour. I will follow up with her upon returning to wok on Friday.

The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 10TH day of MARCH, 2009 , at approximately 5:00  A.M.  P.M. at 619 PONTE VEDRA BLVD. within St. Johns County, violated the law and did then and there: Willfully and unlawfully committed the act of aggravated assault against the victim by pointing a shotgun to his chest while loading a round into the guns chamber. After a verbal altercation with the victim on the beach the suspect went to his vehicle and removed a shotgun from his backseat. The suspect once again confronted the victim in the parking lot and pointed the shotgun to his chest ordering the victim to state that he was a "bitch." The suspect then returned to his vehicle to put away the shotgun the suspect discharged the weapon shooting himself in the foot while the victim ran to get help. Fire rescue responded to the scene but the victim refused transport to the hospital. Fire rescue treated the suspect on scene before being taken into custody. During the incident the victim was in fear of losing his life.
