Original Narrative      Supplemental Narrative

On 082308 at 0220 hours, I was dispatched to a report of a fire at the Chi Phi Fraternity House. Upon my arrival at 0221 hours, I smelled smoke. I also observed smoke on the south side of Chi Phi. The building was partially evacuated upon my arrival. Officers assisted in evacuating the remainder of the building. I approached the south west side of Chi Phi and observed hay smoldering on the ground in front of the emergency exit door. Additionally, there was heavy smoke on the 2<sup>nd</sup> floor of the Chi Phi House. CCFD arrived on scene at 0221 hours. CCFD extinguished the hay that was on fire on the south side and checked the interior of Chi Phi for any additional fire. No fire was found inside the building. CCFD cleared the building and declared it safe. The alarm was reset by Russell Dukes. During the fire, the Chi Phi House sustained fire damage to the awning over the emergency exit door, and the emergency exit door was also charred. There were no injuries reported on scene. Russell Dukes released the building to be reentered. The cause of the fire appeared to be the result of someone lighting the hay next to the building on fire.
